CONTRIBUTIONS

The *Journal of Spatial Science* publishes original *Research and Review Papers* contributing to the theory and development of the spatial sciences. *Professional Papers* describe aspects of professional practise and implementation of techniques related to cartography, geographic information science, hydrography, photogrammetry, remote sensing or surveying.

REFEREEING

All research and review manuscripts will be peer reviewed anonymously by at least two referees. *Professional Papers* are not refereed but are assessed by the Editors. The Editorial Board will make the final decision on publication.

All manuscripts must be the result of original work. Submission of a manuscript implies that it has not already been published and is not under consideration for publication elsewhere. Authors are required to obtain copyright clearance and submit the evidence from the copyright owners for any text or figures that have been published elsewhere when submitting their manuscript. Where such evidence is not provided it will be assumed the material originates from the authors.

FORMAT

Manuscripts should be submitted in English and presented double-spaced, and submitted digitally in Microsoft® Word format. Manuscripts are to be sent by email to the Editor-in-Chief (g.l.wright@curtin.edu.au) with a hard copy sent via airmail to:

In certain circumstances colour reproduction of figures and images may be provided and the hard copy should indicate if this is desirable. The final decision on reproduction style will be determined by the Editors.

LAYOUT AND STYLE

Research and Review manuscripts and *Professional Papers* should conform to the following guidelines.

Title Page. Contains in order the title, the names of authors, an abstract not exceeding 100 words, and the full names and addresses of each author. The corresponding author should be indicated.

Headings. Major headings are in capitals, centred and bold. Middle headings are in upper and lower case, left justified and bold. Minor headings (if required) are in upper and lower case, indented and bold, with text continuing on the same line. Headings should not be numbered.

References. The Harvard system is used. References in the text should appear as *Smith (1988) investigated ...* or *this issue has been investigated (Smith 1988) ...* Only works that are cited in the text should be included in the REFERENCES section of the manuscript. All references should be listed at the end of the manuscript in alphabetical order and structured as follows:

- Maling, D.H. (1989) *Measurements from Maps: Principles and Methods of Cartometry*, Pergamon Press, Oxford.
- Waugh, T.C. and Dowers, S. (1988) High-speed interactive mapping in large topographic databases, *Proceedings of Eurocarto Seven, Enschede, The Netherlands*, September 1988, ITC Publication, pp. 97-109.

Figures. Diagrams, drawings and illustrations should be numbered consecutively as *Figure x* within the text. All figures should appear immediately following the paragraph in which they are first mentioned. Digital copy of all figures should be provided either inserted directly into the file containing the text or included in a separate file. Where hard copy versions only are available, a camera-ready copy should be provided with regard for reproduction requirements of size, detail and contrast. Photographs should be glossy black and white prints.

Tables. Tables should be numbered consecutively as *Table x* and included in the body of the text. All tables should appear immediately following the paragraph in which they are first mentioned.

Equations. Equations should be referenced by consecutive numbers throughout the text, on the right hand side of the page, using (1), (2) etc.

Footnotes. Footnotes should not be used.

Proofs and Reprints. The corresponding author will receive proofs for checking prior to publication and will receive 10 reprints free of charge. Additional reprints may be ordered prior to publication, at cost.

ADDRESS

All contributions must be sent to the Editor-in-Chief, Journal of Spatial Science, PO Box 6836, East Perth, WA, 6892, Australia. Authors should indicate to which section of the Journal their contribution is being submitted, *Research and Review* or *Professional Papers*.
